- That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.

- That the Principal and Correspondent/Manager of the school have individually gone through
  the provisions contained in the affiliation & examination byelaws and the circulars issued by
  the Board from time to time. The school undertakes to abide by the provisions contained in
  the affiliation & examination byelaws, directions issued from time to time and the law of the

  pattern classes without submitting a certificate/affidavit to the effect that the
  school has complied with all the conditions imposed by CBSE and the post-affiliation
  conditions contained in affiliation byelaws along with general rules.
